If you don't switch over you possibly could lose your benefits and have a hassle getting your money back from Tri Care. Your best bet is to check this out and find out how it affects you. This information is to let you know that there are changes coming for those enrolled in Tri Care Prime. Each person reading this needs to determine how this affects them and what action they should take.

HOWDY DUTY BY ANDY LOVE



As with most things that happened to the Colorado Air National Guard in the 20th century, it was all Jack Wilhite's fault. During Christmas vacation of 1966, I was standing at the top of Peak 8 at Breckenridge and looked down the valley to see 4 fighters in fingertip rocketing up the Blue River. They came up the lift and did a star burst at the top of the Peak. At the end of the day, at the Gold Pan Bar, I found 4 guys in flight suits. They didn't have to buy their own beer. One was Wilhite, of course.

But, let me back up a ways. I'm a baby-boomer. I was born when my dad was fighting the war in the Pacific, flying PBYs in the Navy. He went on to serve Colorado as its governor for three terms and when I asked him, just before he died, to tell me about the most important thing he had done throughout those 84 years, he said "serve in the Navy during the War". He had raised me talking about Naval flying so it wasn't a big surprise that I was going to be a military aviator.

I thought I wanted to fly in the Navy. A cold couple of days at Olathe Naval Air Station having a physical over the Thanksgiving weekend of 1966 caused a real gut check on whether that was such a good idea. I figured that Olathe probably looked like all of the other Naval facilities and it was cold, bleak and isolated.

When I ran into Wilhite that day in Breckenridge and asked "where are you guys from", they answered "from Buckley" and told me that they flew for the Colorado Air Guard. That cinched it. No more cold barracks in Kansas and bad food. I wasn't that smart but it wasn't too tough to figure that I wanted to fly fast jets in the blue, Colorado sky and have a beer with pretty girls in ski pants at the end of the day.

So, I went to see Don David, then a major running the recruiting part of the COANG. Don told me each state got one USAF pilot training slot each year and that Colorado's were already allocated to Boomer Hoffman and another guy for the coming two years. If I wanted to join and hang around to see if they could round up one more slot, I was welcome to join as an enlisted guy assigned to be an aircraft mechanic. Sounded like a good solution to me, so I joined on 11 April 1967.

Off to Lackland as an E-nothing in the summer of '67 I was sent to Basic Training. Gurney Ulrich was there to see me off on the C-47. It turned out OK and I came home for some OJT under Bill Hagarty on the dock at the NW corner of 801. Bill was well seasoned and understood what I was qualified to do. He gave me the job of sweeping out the hanger deck at the end of each day. Gradually, he let me turn a wrench and scoot down the intake of the F-100s on his dock. By November, I had finished the obligatory active duty time, had my 5-level in aircraft maintenance and was a seasoned A3C.

The ski season was just getting going and I didn't have much to do while I waited to see if Don David could come up with a slot in Undergraduate Pilot Training. I got a job waiting tables and tending bar in Aspen, found a roommate who had a two-bedroom apartment at the bottom of the hill and settled in for a good winter ski-bumming.

Along came January 26th of 1968 and President Johnson, who by that time desperately needed additional airmen and Guard jets in Vietnam called the ANG to active duty. That ended the ski season for me and I, like all of the rest of us in the 140th, reported to Buckley. It was big news in Colorado and, of course, the Rocky Mountain News sent a reporter and a cameraman to see what was going on. They took my picture climbing out of the intake of one of the jets on the dock and it appeared on the front page the next day under the banner telling the readers that the Air Guard had been mobilized and was going to war.

As most now know, it was all an excuse for the president to access just the experienced guys and leave the rest of us behind. They didn't want a one-stripe airman so I hung around Buckley while others went to Cannon and to Korea. We built model airplanes in the sheet metal shop and flew them off of the top of Hanger 801.

Well, things worked out and someone figured that Wyoming wasn't able to fill a UPT slot because they couldn't find anyone who wanted to fly the C-121 in Cheyenne so they transferred me, for a single day, to the WYANG, awarded me the slot and I was off for UPT in June with a brand new direct commission in the USAF. Major General Joe C. Moffitt and my mom pinned the brown bars on my shoulders.

After pilot training I went to Luke AFB to check out in the F-100, came home and became a part of D-flight in the 120 TFS. We transitioned to the A-7 in 1974 in a home field checkout and flew that wonderful and indestructible jet for 17 years. In 1992 I went back to Luke to learn how to fly the incredible F-16 in a three month course flying to the Goldwater ranges and finding that the bar in the club had changed with the changing times. It just wasn't the rabble-raising place it was in 1969.

I was lucky to be mentored by incredible leaders like Bob Cherry and Walt Williams. John France took me under a wing and taught me lots about flying and lots about the Air Force. Colonel Cherry was a gruff guy on the outside and didn't tolerate guys who were dangerous but, if you could fly, he gave you a little slack. Walt "Redeye" Williams had such pride in the Colorado Guard that we couldn't help but feel a little taller flying on his wing. Wayne Schultz ran the squadron, the group and wing in his quiet but firm way that generated a level of loyalty unlike any other. We all marched in formation for the change of command putting Mase Whitney in charge of the wing and the only blemish on his outstanding leadership career was our marching. It was the last time I can recall the entire wing being ordered to march, for good reason. We did a miserable job, particularly 8 abreast confronted with a turn.

Thirty seven years later I retired from the USAF, having spent an entire career in the Air Guard. Together we all had a chance to see the world, have some incredible experiences, bond with the best people in America, be proud that we served at a time when it wasn't popular to wear a uniform and, in the process be part of the force that won the Cold War.
